Dear Parents/Guardian,

You are fully aware of the orders of the AICTE and of Hon'ble Supreme Court on the Anti-Ragging measures (Copy of the ***AICTE Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009*** available on the college website).

It has been made mandatory by AICTE and Hon'ble Supreme Court that all students and parent/guardians are required to submit an affidavits before a student is allowed for admission in the College.

The format of affidavits can be obtained from *Registrar's office* of the Trivedi Institute Of Management & Technogy or can be downloaded from our website ***www.timt.info*** in and submit on a Non-Judicial paper of Rs.10/- duly attested by the oath commissioner/notary. All parents/guardian/students may submit the same and get them duly attested by the Oath commissioner and ***bring it on the day of student's admission .***

Kindly note that there are two Affidavits as Annexure-I & II. The Annexure-I is to be signed by the student and Annexure-II shall be signed by the parent / guardian.

In case a student does not submit the same he/she shall not be allowed to the classes. It is further, requested that this information be passed amongst friends.

AFFIDAVIT BY PARENT/GUARDIAN

- 4) I hereby solemnly aver and undertake that
 - a) My ward will not indulge in any behaviour or act that may be constituted as ragging under clause 3 of the Regulations.
 - b) My ward will not participate in or abet or propagate through any act of commission or omission that may be constituted as ragging under clause 3 of the Regulations.
- 5) I hereby affirm that, if found guilty of ragging, my ward is liable for punishment according to clause 9.1 of the Regulations, without prejudice to any other criminal action that may be taken against my ward under any penal law or any law for the time being in force.
- 6) I hereby declare that my ward has not been expelled or debarred from admission in any institution in the country on account of being found guilty of, abetting or being part of a conspiracy to promote, ragging; and further affirm that, in case the declaration is found to be untrue, the admission of my ward is liable to be cancelled.
- 7) In addition to the above, I hereby also undertake and confirm that on all matters of Academic, Administration and Discipline in r/o. my ward, the decision of the college authorities shall be final and binding on me.
